COVID-19 Precautions

In-person attendees are **REQUIRED** to be up-to-date with their COVID-19 vaccinations. Per current Centers for Disease Control and Prevention (CDC) guidelines, adults (age 18+) are considered up to date as follows:

- Primary vaccination series was Pfizer-BioNTech or Moderna: Booster dose (with either Pfizer-BioNTech or Moderna, regardless of initial vaccination type) received at least 5 months after the last dose in the primary series.
- Primary vaccination was Johnson & Johnson's Janssen: Booster dose with either Pfizer-BioNTech or Moderna at least 2 months after the first dose. The booster dose may be with Johnson & Johnson's Janssen vaccine in some situations.
- Immunocompromised registrants are encouraged to follow vaccination guidelines for moderately or severely immunocompromised people and to explore with their doctor receiving an infusion of Evushield (tixagevimab/cilgavimab) prior to attending the conference.
